FUNDING AGREEMENT FOR ST CHARLES' RC PRIMARY SCHOOL

I am pleased to inform you that I have agreed to enter into a Funding Agreement with you to allow St Charles' RC Primary School to convert into an academy. My officials will forward a copy of the executed Funding Agreement to you.

The date of conversion, when the school will open as an academy, will be 1 April 2021. I am writing to Newcastle City Council to instruct it to cease maintaining the school from that date.

If you have notified the Department of any additional leases or subleases the academy trust wishes to grant on conversion, these will also require my consent (according to the terms of both the Funding Agreement and the relevant legislation), and we will soon write separately in relation to this.

Academies form an integral part of the Government's education policy to raise attainment for all children. I am delighted that St Charles' RC Primary School recognises the benefits academy status will bring.

FUNDING AGREEMENT FOR ST CHARLES' RC PRIMARY SCHOOL
